“The proposals in respect of the Financial Assistance from Welfare Fund for setting up/ upgradation/ refurbishing of Crèche in Commissionerates should be forwarded by the Commissioner/HoD. For this purpose, an Advisory Committee comprising the Commissioner/ officers of equivalent rank in the department and one representative each of Group ‘A’ to ‘C’ (erstwhile group D, uniformed officer) be nominated in each Commissionerate/ Directorate. The decisions arrived at by the Advisory Committee on each proposal should be forwarded to the Governing Body with full details/ justifications for further consideration and sanction.”

The above mentioned para is for all types of proposals for crèche i.e. for setting up/ upgradation/ refurbishing. Hence, all the Commissionerates/ Directorates may send in their proposals for Financial Assistance from Welfare Fund for setting up/ upgradation/ refurbishing of Crèche with Minutes of Meeting of the Advisory Committee along with all the necessary documents.
