Subject: Hiring of 876 Additional Operational Vehicles-Reg.

The undersigned is directed to refer to proposal No. EMC/ExpM/VEH/10/2021-EMS dated 03.09.2021 from the Directorate General of Human Resource Management (DGHRD) on the subject cited above and to convey the one time financial approval of the competent authority for hiring of 876 mid-sized operational vehicles (one for each of the 769 Divisions and one mid-sized vehicle for each of the 107 GST Commissionerates). The details of the hiring of 876 mid-sized operational vehicles in respect of 21 Central Tax (CGST) Zones given as under.

2. Further, the hiring of the above mentioned additional operational vehicles is subject to the following conditions:

- i. The vehicles shall be hired for the following purposes namely, verification of registrations, verification of risky exporters, verification of fake dealers, cases of fake invoices, taking arrested individuals safely to Courts/Prison and attending legal matters in Courts etc.
- ii. The vehicles meant for Divisions shall not be diverted to Commissionerate or Zonal Headquarters.
- iii. The vehicles may be hired only on the basis of actual requirement and may not be used as staff cars.
- iv. The vehicles shall be hired within the cost ceiling as revised through IFU's OM No. 6/1/2019-IFU/EC.II dated 11.02.2019.
- v. The existing instruction of DoR and provisions of GFR 2017 to be followed.
- vi. The hiring of vehicles will be effective prospectively i.e. from the date of issue of sanction order;
- vii. Proper log book shall be maintained by the formations on the hired vehicles;
- viii. The hiring may be discontinued immediately when the vehicles are no longer required for the offices for which these are sanctioned.
