Subject : Calling for options for posting of officers (promoted on in-situ basis and expecting promotion to the Grade of Commissioner)-reg

It is informed that DPC for promotion of 2005-2006 Batch IRS (C&IT) officers to the grade of Commissioner has been conducted and officers on promotion will be due for placement in terms of Transfer/Placement Guidelines, 2018.

2. Please also refer to Board's office order no. No. 85/2023 dated 31.05.2023 and 88/2023 dated 31.05.2023 wherein officers have been promoted to the grade of Principal Commissioner of Customs & Indirect Taxes in the Indian Revenue Service (Customs & Indirect


Taxes) on in-situ basis. Also, please refer to Board's office order No. 61/2023, 62/2023, 63/2023, 64/2023 all dated 10.05.2023 and office order No. 66/2023 dated 11.05.2023, wherein officers have been promoted as Assistant Commissioner from Group 'B' on in-situ basis. Further, one officer has been promoted as Joint Commissioner vide Board's office order No. 81/2023 dated 25.05.2023 on in-situ basis.

2. Hence, it is decided with the approval of the Competent Authority to open DGHRD portal (AGT module) for transfer/posting representations of officers of 2005-2006 batches and for the officers, promoted on in-situ basis, as above.

3. Accordingly, it is requested to inform the officers concerned under your charge mentioned in para 01 and 02 above to make representations only through the portal (<https://dghrdcbic.gov.in/agt>). While making the representation provisions of Transfer/Placement Guidelines, 2018 (Para 4.8 /4.9) may be kept in mind which is applicable for promotion cases. Also, in case officer is representing on any compassionate ground (as per Para 11) the officer must attach relevant documents. The portal will open on 17/06/2023 and window for filing representation will be available till 02/07/2023 midnight.
