Dear Sir / Madam,

During the current fiscal year 2021-22, CBIC has earmarked a fund of Rs.60 Crores under Swachhta Action Plan (SAP), under the head O.E. (Swachhta), which has been distributed to the Budgetary Authorities under CBIC. It is requested that Pr. Chief Commissioners / Pr. Directors Generals / Chief Commissioners / Director Generals may identify at least two Swachhta projects within their zones. Similar action may also be taken by each Commissioner within his / her jurisdiction. Details of the respective projects may be informed to ADG, HRM-II by the 15th July, 2021, in the format enclosed.


2. Until May 2021, only 1.12% of the amount has been spent from OE (Swachhta) fund allocated to the Zones/ Directorates during the current financial year 2021-22. It is requested that activities under the Swachhta action plan may kindly be taken up in right earnest quickly, so as to avoid bunching of expenditure towards the end of the Financial Year.

3. The evaluation of Swachhta Projects 2020-21 on the basis of highly objective and scientific methodology, is under process. During the current fiscal year as well, the Swachhta projects shall be evaluated using the same criteria and Swachhta awards shall be given to the best performing GST zone, Customs zone, Directorate and Commissionerates.

4. I request that the field formations act promptly on the identification and execution of the Swachhta Projects so that we all may contribute towards implementing the "Swachh Bharat Mission" in a committed manner so as to achieve the goal of "Swachh Bharat, Shreshtha Bharat".
