5. Method of recruitment, age limit, other qualifications:

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in column 5 to 13 of the Schedule aforesaid.

6. Initial constitution: Notwithstanding the provisions of rule 3, a provision holding the post of Superintendents of Customs (Preventive) Group 'B' at the commencement of these rules, shall, after appointment thereto on a regular basis in a substantive or officiating capacity, be deemed to have been appointed to the post of Superintendent of Customs (Preventive) Group 'B' in the cadre to which the post is allocated under rule 4 above, in a substantive or officiating capacity respective and shall, except where an officer holds the said post on an officiating capacity is confirmed in an order different from the order of the seniority after such commencement, be senior to those appointed to the post after such commencement.

7. Disqualifications: No person -

- (a) who have entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living has entered into or contracted a marriage with any person;
- shall be eligible for appointment to any of the

said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from operation of this rule.

8. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient so to do it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

9. Interpretation: If any question arises as to the meaning or application of these rules or any of them to any person, the matter shall be referred to the Government, whose decision thereon shall be final.

10. Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories in accordance with the orders issued by the Central Government from time to time in this regard.
