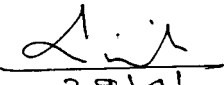

3.0 All representations received through proper channel in this regard up to 28.04.2020 stand disposed of.

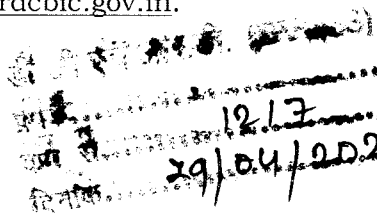
