Subject: Proper monitoring of Swachhta Projects 2022-2023.

Please refer to this office letter of even no. dated 11.05.2022 and subsequent reminder issued vide letter of even no. dated 05.09.2022, whereby it was requested to draw an action plan and identify Swachhta Projects and upload on Swachhta@CBIC Module, so that Swachhta Funds may be utilized optimally.

2. However, it is observed from the module i.e. Swachhta@CBIC that as on 10.11.2022, 183 formations have yet not submitted details of the Swachhta Projects for the current financial year 2022-23 (list enclosed as **Annexure A**).

3. Further, it is also observed that out of total fund allocated under O.E. (Swachhta Head) which is Rs. 54.25 Cr., only an amount of Rs. 12.26 Cr. has been incurred till September 2022. Thus only 22.6 percentage of total fund (allocated) is utilized in the first six months of the current financial year, which is very low.

4. It is therefore, once again requested to identify the swachhta projects for your respective jurisdictional offices and ensure the uploading in the module so that the funds are utilized optimally and bunching of expenditure towards end of financial year is avoided. Further, the formations may also like to emphasize on sustained usage of the assets created under Swachhta in the

last financial years by way of continued support/maintenance.
