G.S.R. 229 . In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following amendment in the Narcotics Department (Group 'B' posts) Recruitment Rules, 1984, namely:-

G.S.R. : 425 : In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Narcotics Department (Group 'B' posts) Recruitment Rules, 1984, namely:-

1. (1) These rules may be called the Narcotics Department (Group 'B' posts) Recruitment (Amendment) Rules, 1988.
- (2) They shall come into force on the date of publication in the official Gazette.
2. In the Schedule to the Narcotics Department (Group 'B' posts) Recruitment Rules, 1984,
 - (a) for the existing entries under column 2, the following shall be substituted, namely:
" 39 * (1988)
*Subject to variation dependent on workload
 - (b) for the existing entries under column 4, the following shall be substituted, namely:
"Rs. 2000-60-2300-BB-75-3200-100-3500";
 - (c) for the existing entries under column 12, the following shall be substituted, namely:

- 2 -

" Group 'B' DPC (for promotion):

1. Narcotics Commissioner
2. Chief Controller of Factories
3. Dy. Narcotics Commissioner (Hqrs.) - Member.

Note: The senior of the first two officers shall be the Chairman of the DPC and the other shall be Member".
